Our Statement of Purpose

AIMS AND OBJECTIVES

1. Promote good oral health to all patients attending our practice for care and advice
2. Provide high quality dental care, including periodic examination and treatment, where required
3. Understand and meet the need of our patients, involve them in decisions about their care and encourage them to participate fully

4. Involve other professionals in the care of our patients, where it is in the patient's interest's interests for example, referral for specialist care and advice
5. Participate in local initiatives to promote the benefits of general and oral health to the wider population
6. Ensure that all members of our team have the right skills and training to carry out their duties competently and with confidence

Ensure an awareness of current national guidelines affecting the way we care for our patients.

REGULATED ACTIVITY 1 TREATMENT OF DISEASE, DISORDER AND INJURY

Services:-

- **The treatment of dental disease including caries and periodontal disease**
- **Orthodontic assessment**
- **Treatment of oral trauma**

By this we mean:

Following diagnosis and screening, patients are given an explanation of any items requiring attention, all appropriate treatment options and associated costs (where applicable) and the pros and cons of each option is explained.

The kinds of services that we provide are consultations, x-rays, treatment of periodontal disease, routine restorative work such as fillings, crowns, inlays and onlays, endodontics, prostheses and cosmetic work. If necessary, referral to specialist dental practitioners may be advised where the treatment required is more complex, such as in the case of more difficult instances involving endodontic and periodontal care or specialist care such as orthodontic treatment and dental implant placement and restoration.

In the case of injury, temporary treatment may be provided to stabilise the mouth. Patients will be kept fully informed of proposed interventions at each point, receive itemised estimates of likely costs and consent will be sought at each stage. At all times we aim to provide a service based on prevention and develop a personal regime for each patient within this overarching framework.

REGULATED ACTIVITY 2 SURGICAL PROCEDURES

Services:-

- **The treatment of dental disease including caries and periodontal disease**
- **Orthodontic assessment**
- **Treatment of oral trauma**

By this we mean:

If a patient requires a surgical procedure at the practice, and we believe that this is within our skill set (such as routine or more straightforward surgical extractions and apicectomy) then we

will explain the procedure to the patient together with any associated risks and, if the patient wishes to proceed, obtain appropriate valid consent. Once completed, we will monitor the progress of the patient in accordance with the relevant clinical protocols to ensure that recovery is both full and uneventful.

For more advanced surgical procedures, such as the removal of impacted wisdom teeth, we refer to appropriately qualified consultants and specialists either in hospitals or a practice environment. For implant placement, we will refer the patient to the appropriate qualified specialist.

We aim to meet the routine and general dental care needs of our patients and try to achieve high levels of oral health through adopting a preventive approach. If the users of our services require or request to have a treatment or procedure that we are either unable or unwilling to provide, then we will either arrange for a referral or inform them accordingly.

REGULATED ACTIVITY 3 DIAGNOSTIC PROCEDURES

Services:-

- **Diagnosis of dental disease including caries and periodontal disease**
- **Radiographs – taking and diagnosing**
- **Soft tissue screening**

By this we mean:

We aim to see each patient at a personal and mutually agreed recall interval and perform a full examination of both the hard and soft tissues and supporting structures of the oral cavity using diagnostic aids such as x-rays as and when appropriate. Where any abnormalities are detected then further investigations such as biopsies and actions such as referrals will be actioned.
